**GENERAL TERMS:** Minimum order of US \$500.00 applies for all sales (For exceptions, please talk to R S Brothers LLC and get approval). Full payment must be paid prior to shipment. You may place the order via E-Mail, Fax / Mail.

**PRICING INFORMATION; AVAILABILITY DISCLAIMER :** All prices are mentioned in US Dollars and are subject to change without any prior notice. Invoice will reflect any change in prices. You can get price quote by E-Mail or Fax. Once you place the order, we will e-mail you in 24-48 hours with a confirmation letter along with payment instructions (Total cost including shipping charges). Customs charge is Buyers' responsibility. We are not responsible of any customs/tax/duty and other related fees. Please check Customs Regulation in your country for detailed information. We accept wire transfer or LC. Seller reserves the right to make adjustments to pricing, Products offerings for reasons including, but not limited to, changing market conditions, Product discontinuation, Product unavailability, manufacturer price changes, supplier price changes and errors in advertisements. All orders are subject to Product availability. Therefore, Seller cannot guarantee that it will be able to fulfill Customer's orders. **SHIPPING:** We prefer FOB shipment. For FOB shipment, buyers are requested to place the order only when you are ready to pick up the package within one week time period or an estimated pick up time must be provided. Otherwise, a reasonable storage fee will be applied. Yet, at the Buyers' request, we will do C & F (Cost & Freight) shipping. We expect 90% of payment on receipt of PO confirmation and the remaining 10% on readiness of goods for shipping. Your orders will be shipped directly from manufacturers in USA or from their authorized dealers or their own plants in other part of the world to your shipping address within 5-7 working days of receiving your full payment confirmation. Orders larger than 12 feet length need to be shipped via sea. Other orders maybe shipped via sea or air as requested by the buyer. We will not be responsible for any delay in delivery related to unforeseen events and circumstances such as natural disasters. On all export orders, legal title and responsibility for goods is transferred to the buyer at shipping point, or warehouse. Charges for postage, insurance, shipping, special consular certification, export documentation, legalization and/or special packing will be added to your invoice.
